

Seventeen Drug Sweep Suspects Make First Appearance

(KAIR) -- Seventeen suspects from the December 19th Atchison drug sweep made their first appearances Friday morning in Atchison County District Court.

While a majority of them have posted a 25 thousand dollar bond, some of them are at risk of heading back to jail.

Friday in Atchison County District Court, Judge Martin Asher gave Emerson Downing, Luke Crawford, Jody Crawford, Brenda Castillo, Tamara Jackson and Eldon Roles until next week to pay the 100 dollar fee.

Most of the cases were continued Friday one to two weeks.

Some have opted for preliminary hearings including Michael Scott and Ernest Crawford for January 24th and Kyle Ferris for January 15th.

Two suspects had their bonds revoked already; Steven Oswalt for allegedly not showing a bond mandated urine analysis and Holli Sledd for failing a UA.

Ferris and Ebony Knott have remained in Atchison County Jail since their arrest.

Possession of a narcotic with intent to distribute, distribution of a narcotic (5 counts), no drug tax stamp (6 counts), conspiracy to distribute a narcotic

Distribution of a narcotic (4 counts), no drug tax stamp (4 counts)

5) Michael W. Scott, 54, Atchison

Distribution of a narcotic (2 counts), no drug tax stamp (2 counts), use of a telecommunication facility to facilitate a controlled substance transaction

6) Tamara A. Jackson, 46, Atchison

Distribution of a narcotic (2 counts), no drug tax stamp (2 counts)

7) Norman "Nicky" Ford, 39, Atchison

Distribution of a narcotic (2 counts), no drug tax stamp (2 counts)

8) Brenda S. Castillo, 50, Atchison

Distribution of a narcotic, no drug tax stamp, unlawful representation that a noncontrolled substance is a controlled substance

9) Michael Moeck, Atchison

Distribution of a narcotic, No drug tax stamp and use of a telecommunication facility to facilitate a controlled substance transaction.

10) Marcus T. McGowan, 28, Atchison

Distribution of a narcotic (2 counts), no drug tax stamp (2 counts)

Use of a telecommunication facility to facilitate a controlled substance transaction

11) Amy L. Collins, 35, Atchison

Distribution of a narcotic, no drug tax stamp, conspiracy to distribute a narcotic, use of a telecommunication facility to facilitate a controlled substance transaction

12) Eldon "Leroy" Roles, 48, Atchison

Possession of a narcotic with intent to distribute, no drug tax stamp

Distribution of a narcotic (2 counts), no drug tax stamp (2 counts),

Conspiracy to distribute a narcotic, use of a telecommunication facility to facilitate a controlled substance transaction (2 counts)

16) Stephen "Owen" Oswald, 49, Atchison

Distribution of a narcotic (2 Counts), no drug tax stamp (2 counts),

Use of a telecommunication facility to facilitate a controlled substance transaction

17) Kyle I. Ferris, 23, Atchison
